



# Anti-Bullying Policy for Youth Football and Cheer Teams

At La Costa Canyon Pop Warner, we are committed to fostering a safe, respectful, and inclusive environment for all participants. Our anti-bullying policy is designed to uphold these values and ensure that every player and member of our cheer and football teams can thrive without fear of bullying. Bullying is unacceptable, and we have established a zero-tolerance approach to address such behavior.

## **Policy Guidelines:**

## 1. Investigation and Communication:

- The head coach is responsible for promptly investigating any concerns related to bullying. The Board will investigate, if concerns arise that sufficient action has not been taken.
- Upon receiving a bullying concern, the head coach will meet with the affected player and their parents to discuss the reported incident.
- Open communication channels between the coaching staff, players, and parents are vital to address concerns and ensure transparency.

## 2. Warning and Education:

- As a first step, the head coach will issue a formal warning to the player involved, emphasizing the organization's zero-tolerance policy for bullying.
- The coaching staff will take this opportunity to educate the player on the negative impact of bullying and encourage positive behavior.

#### 3. First Offense Consequences:

- In the event of a second bullying incident, **the player will face a one-game suspension**.
- The player must attend the game but will not be allowed to participate in the game or wear their uniform.
- If the player misses the game without a valid reason, they will automatically be suspended for the subsequent game.

## 4. Second Offense Consequences:

- A third bullying incident will result in the immediate removal of the player from the team.
- The coaching staff and Board decide to remove a player after thorough consideration.

#### **Educational Approach:**

- Alongside consequences, our organization is committed to educating players about the importance of treating each other with respect and empathy.
- Team meetings, workshops, and discussions will be organized to address bullying, promote unity, and provide tools for conflict resolution.





#### **Reporting and Confidentiality:**

- We encourage all players, parents, guardians, and coaching staff to report any instances of bullying promptly.
- Reports will be handled sensitively, and confidentiality will be maintained to the extent possible.

## **Online Bullying and Communication Policy**
